The Board of Directors of Pan Asian Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to announce that Pan Asian Manufacturing (Tianjin) Co Ltd (“PAMT”), a wholly owned subsidiary of the Group, has initiated arbitration proceedings against Tong Zhou Construction Co Ltd (“Tong Zhou”) in connection to the construction contract the company signed with Tong Zhou on 31st May 2011.

The company has filed for arbitration at Wuxi Arbitration Commission to seek to terminate the contract and claim for the refund of deposit paid of RMB 7.8 million.
